- o Jackie Deloplaine-All Hazards Fusion Center
  - i. What is the Fusion Center –empower homeland security partners through the lawful gathering, analysis and sharing of threat-related information. They provide information and support to incident management and response/recovery coordination activities
  - ii. Jackie's concentration is on Cyber Security and is a serious threat today and can affect everyone
  - iii. Shares tips-don't keep electronics out in the open
  - iv. With children-set rules-provide dangers monitor activity and communications
  - v. Phishing-growing in popularity—starts by "click link and send .... Money –information etc.
  - vi. Security –set your device setting to require 2 factor authentication-text email –(be careful of nest cams they can be accessed by others)
  - vii. Jackpotting- need 2 people to do this-involves gaining access to the ATM via malware on the ATM. Usually one person is in a vehicle, the other inserts a card and cash is dispensed
