# Public Safety Report

Brittany Goldinger provided summary of August and September Northside Public Safety Council meetings (held via Zoom) and details on Fall 2020 Student Police Academy and Citizens' Police Academy programs (deadline for application is 09/18, this Saturday)

Extensive conversation at this time occurred with concerns expressed by Chris Waraks and Bob Sobocinski regarding shooting fatality of 1 year old baby in Rhine Court. (3 arrests have been made). Erin Tobin and Bobby Wilson have been in contact with property management (Councilman Wilson is planning a walk through of property to discuss safety, trash, and parking remediation strategies). Laura Washington is management contact for the property. All agreed

on commitment to resources and support for this neighborhood community.

#### Sept. 12th volunteer service with DF Legal

Erin Tobin provided details of successful event focused on weed removal. 15 volunteers from DF Legal, and community volunteers, worked on the mosaic, Western PA Conservancy Garden, Itin Street, and the Waisenhaus Lot.

#### 4. New Business

#### Update from Councilman Wilson

His office is currently addressing issues with storm water/catch basin repair.

His Chief of Staff Sally Stadelman met with Erin and Ellen to discuss neighborhood cleanup and fence repairs. They are moving forward with addressing these issues through either DPW or SHCL volunteer efforts.
